



ShieldAll® 6023 Twenty-Five Year Limited Warranty

Protective Chemistries Incorporated (PCI) warrants to the applicator of ShieldAll® 6023 Fire and Smoke Resistant Coating (ShieldAll®6023) that, for the twenty-five year limited warranty period from the application date, ShieldAll® 6023 will, when exposed to fire, reduce flame spread and smoke spread by forming and expanding protective char and will slow the burn-through of combustible construction materials under normal operating building conditions when applied to a clean exposed surface in strict accordance with the application guide located on the ShieldAll® 6023 [Technical Data Sheet](#) and the additional requirements of this Warranty. A current copy of the product data sheet may be obtained from PCI via the website, <http://www.protectchem.com> or contacting PCI directly. For any valid claim presented under this Warranty, PCI will provide a refund for the cost of the ShieldAll® 6023 used for the individual dwelling or unit of the application that failed.



Qualification. To qualify for this Warranty, all of the following requirements must be met: • The substrate for application must be free of all dirt, debris, mold or other materials that will impede bonding of ShieldAll® 6023 to the substrate surface. • ShieldAll® 6023 must be applied in accordance with the material application guide located on the [Technical Data Sheet](#).

Exclusions. This Warranty does not cover, and PCI will have no liability for any damage or failure of ShieldAll® 6023 caused by, or due to, any of the following: • Use of ShieldAll® 6023 that is applied one year after purchase date. • Surface alterations, including painting, on the finished ShieldAll® 6023 surfaces. • Mold growth on accumulated material or debris on the ShieldAll® 6023 surface. • Removal, replacement and/or alterations to the surfaces treated with ShieldAll® 6023 made prior to notifying PCI of any claim.

Warranty Claims.

Limitation of Liability. IN THE EVENT OF ANY BREACH OF LIMITED WARRANTY SET FORTH HEREIN, PCI'S SOLE LIABILITY, AND THE APPLICATOR'S SOLE REMEDY, SHALL BE TO REFUND THE AMOUNT PAID FOR ANY SHIELDALL® 6023 MOLD RESISTANT COATING THAT IS FOUND TO BE DEFECTIVE. For a claim to be considered valid by PCI, the following conditions must be met: •THE APPLICATOR MUST NOTIFY PCI WITHIN 10 DAYS OF THE DISCOVERY OF THE ALLEGED DEFECT IN THE SHIELDALL® 6023 PRODUCT COVERED BY THIS LIMITED WARRANTY. •APPLICATOR WILL ARRANGE TO PROVIDE PCI WITH A REASONABLE OPPORTUNITY TO REVIEW AND INVESTIGATE THE ALLEGED DEFECT. •APPLICATOR WILL SUPPLY A COPY OF THE WARRANTY AND WARRANTY REGISTRATION TO PCI WHEN MAKING A WARRANTY CLAIM. This limited warranty is in place of all other warranties, express or implied. PCI expressly disclaims any other warranties, including warranties of merchantability and fitness for a particular purpose. Although PCI may have suggested ShieldAll® 6023 for an application, it is the sole responsibility of the applicator to determine the suitability of ShieldAll® 6023 for the intended use and purpose. The applicator assumes all risk and liability whatsoever regarding such suitability. The remedy stated in this Warranty takes the place of all other remedies against PCI, and is the only remedy against PCI available to the Applicator or any other party related to the purchase and use of ShieldAll® 6023. In no event will PCI be liable for any special, indirect or consequential damages (including, but not limited to, lost profits, lost sales, injury to person or property or any other damages) arising out of the sale or use of ShieldAll® 6023 or for any use or misuse of ShieldAll® 6023, regardless of the legal theory claimed, whether in tort or otherwise. Notification of Claim.
